#### REGISTERED DESIGNS

- Registered Community design (RCD) can be registered through OHIM. The registration provides uniform protection throughout the European Union with a single application.
- Unitary character → protection begins and ends at the same time throughout the Community
- A design protects the appearance of a product
- Key prerequisites for the registration of a design:
  - Novelty
  - Individual character
  - Capable of graphical representation



#### BENEFITS OF DESIGN REGISTRATION

- Registration creates a monopoly to the owner of a product
- Registration reduces risks and ensures that the company obtains the exclusive right to use a particular design
- In the modern world, most valuable assets can be intangible: registered IP rights can be sold, licensed, or otherwise exploited
- Registration is generally fast and easy: online filings are registered within a couple of days
- Where the applicant does not have its domicile or its principal place of business or a real and effective industrial or commercial establishment in the European Union, it must be represented by a representative, otherwise the applicant will be requested to appoint a representative within a time limit of two months.



#### **EXPLOITING YOUR RIGHTS**

- A registered design provides you with a certificate, which makes it easy to prove ownership
- Registrations are important part of the process of creating a strong brand
- Registration gives security: companies can be sure that they do not interfere with other companies' IP rights
- Also unregistered Community designs are entitled to protection, but for a shorter period and only against intentional copies i.e. copies made in bad faith


